- a true, exact, and complete copy of the original documents issued to you that confirms you are a U.S. citizen or national or an eligible noncitizen that is acknowledged in the notary statement below AND
- the original notarized Student Certification of Citizenship/Immigration Status below

Or: If the student is able to appear in person at Marguette Central to verify citizenship/nationality, the student must provide:

- 1) presenting an unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or Passport AND
- 2) presenting an unexpired original valid documentation that confirms you are a U.S. citizen or national or an eligible noncitizen
