1. A copy of the unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or signed passport that is acknowledged in the notary statement below, AND
2. A true, exact, and complete copy of the original document(s) issued to you that confirms you are a U.S. citizen, national, or eligible noncitizen that is acknowledged in the notary statement below, AND
3. The original notarized **Student Certification of Citizenship/Immigration Status**, below, signed in the presence of a U.S. Notary.
